We offer a full range of support, education, complementary therapies, and prevention resources related to improving the vitality of those managing a cancer impact. In 2024-2025, more than 23,100 client visits were made by a total of 2,566 unique individuals. Clayton's House, a hospitality home for clients and their care partners to stay at when receiving treatment in the Greater Portland area, served as a "home away from home" provided a total of 277 overnight stays, equating to more than 23,450 miles or \$72,000 saved in transportation fuel costs. The Dempsey Center provides its services in-person and virtually, giving clients choice and reducing barriers to access.
